Notification by EFB-Elektronik GmbH about REACH: Ordinance No. 1907/2006/EG

Dear Sir/Madam,

The new European chemicals regulations REACH came into effect on 1 June 2007, which led to the beginning of various deadlines to fulfil the requirements of REACH.

We receive numerous enquiries about our products with regard to registration status, usage, approval or SVHC materials that are contained. We have decided to reply by means of a standardised letter.

We strive to maintain the product portfolio. Should any serious changes occur in future with regard to the marketing capabilities or the application of a material, we shall communicate this immediately and offer alternatives at an early stage.

From us you receive exclusively products according to Article 3 of the REACH ordinance. Because no substances are emitted from our products under conditions of proper intended use and reasonably foreseeable conditions of application, we are exempt from the requirement to register contained materials.

The following activities provide an overview of the current implementation of REACH by EFB-Elektronik GmbH.

- We have questioned our partners within the supply chain and can inform you as follows:
- Should receive an item that contains material >0.1 weight-% that is on the ECHA list of substances of particularly high concern, you will find explicit information on this on each delivery
- The conditions of restricted substances and their restricted use are observed and updated as soon as new restrictions are imposed.
- We monitor the updating of the candidate list and inform you of any changes.
